<p><u>ACD 106</u></p> <p>Senior Vice President and Provost, Vice Provosts, and Vice Presidents</p>	<p>Revision of Policy</p> <p>Revised to update terminology</p>
<p><u>ACD 107-01</u></p> <p>University Deans</p>	<p>Revision of Policy</p> <p>Revised to change the name of the Honors College</p>
<p><u>ACD 108</u></p> <p>Center Directors</p>	<p>Revision of Policy</p> <p>Revised to change a position title</p>
<p><u>ACD 110</u></p> <p>Reporting Lines for Centers and Institutes</p>	<p>Revision of Policy</p> <p>Revised to include ASU East as a campus where faculty tenure may reside</p>

<p><u>ACD 124</u></p> <p>University Employee Recognition Program</p>	<p>Revision of Policy</p> <p>Revised to replace detail with a link to the Human Resources Employee Resources Web page</p>
<p><u>ACD 405</u></p> <p>Americans with Disabilities</p>	<p>Revision of Policy</p> <p>Revised to emphasize equal opportunity instead of equal employment opportunities; to delete the subsection “Qualifications, Tests, Inquiries” under “Employment” and the sections “Records,” “Drug and Alcohol Abuse,” “Program Accessibility,” “Structural Changes and Renovation,” and “Auxiliary Aids and Services”; and to change the definitions of “auxiliary aids and services,” “qualified individual,” and “reasonable accommodation”</p>
<p><u>ACD 509-01</u></p> <p>University Ombudsperson Committee Guidelines</p>	<p>Revision of Policy</p> <p>Revised to change to 15 days the time frame for the respondent to submit a written response to the ombudsperson, to change the section “Resolutions of the Complaint/Termination of Mediation,” and to update terminology</p>
<p><u>ACD 509-02</u></p> <p>Grievance Policies and Procedures for Faculty</p>	<p>Revision of Policy</p> <p>Revised to add a source; to discuss expectation of cooperation with grievance hearings and subpoena power of the committee; to change a section relating to counsel participation in hearings; to give the president 45 days to decide the matter and forward a written statement to the grievant; and to insert material pertaining to a dissatisfied grievant requesting reconsideration</p>
<p><u>ACD 602</u></p> <p>Employee Reduced In-State Tuition</p>	<p>Revision of Policy</p> <p>Revised to change the title and replace text with a link to this policy in the SPP manual</p>
