RSP 405 Proprietary Research	Revision of Policy Revised to add a link to the "Assurance of Ability to Meet Contractual/Confidential Data Information" form; to insert that protected information must qualify as proprietary or confidential under Arizona law; to specify the <i>Arizona Revised Statutes</i> that comprise the Arizona Public Records Act; to clarify university publishing rights and student's rights and restrictions regarding research and dissertation requirements; to replace the heading "Acceptable Restrictions" with "Permissible Delays"; to update the timeframe for sponsor review of materials for confidential or proprietary information; to expand the Cross References
RSP 406 Publication	Revision of Policy Revised to update the source citation of the <i>Arizona Board of Regents Policy Manual</i> ; to provide the URL for the <i>1940 Statement of Principles of Academic Freedom and Tenure</i> set forth by the American Association of University Professors and the Association of American Colleges; to link to definitions for "Academic Freedom," "Export Control," and "Tenure"; to replace the heading "Acceptable Restrictions" with "Permissible Delays"; to update the timeframe for sponsor review of materials for confidential or proprietary information; to update the requirements for a waiver of the university policy
RSP 503-05 Subcontracts/Subaward Agreements	Revision of Policy Revised to properly cite the Office of Research and Sponsored Projects Administration (OSPRA); to state that ASU has an approved procurement system through February 2, 2010
