<p><a href="#"><u>STA 502-01</u></a></p> <p>General Building Rules</p>	<p><b>Revision of Policy</b></p> <p>Revised to restrict the movement of furniture within the Memorial Union</p>
<p><a href="#"><u>STA 502-02</u></a></p> <p>Reserving and Using Memorial Union Facilities</p>	<p><b>Revision of Policy</b></p> <p>Revised to add an e-mail address for reserving rooms in the Memorial Union, to change the dates during which off-campus groups can reserve space from “predetermined” to “as available,” and to define where, when, and how signage or decorations may be used in the MU</p>
<p><a href="#"><u>STA 502-06</u></a></p> <p>Petitioning and Distributing and Posting Literature</p>	<p><b>Revision of Policy</b></p> <p>Revised to withdraw the use of bulletin boards within the Memorial Union</p>
<p><a href="#"><u>STA 502-07</u></a></p> <p>Lost and Found Items</p>	<p><b>Revision of Policy</b></p> <p>Revised to change the 60-day limit for holding found items in the Memorial Union to 90 days</p>
<p><a href="#"><u>STA 502-09</u></a></p> <p>Locker Use</p>	<p><b>Revision of Policy</b></p> <p>Revised to restrict the use of lockers within the Memorial Union to a daily basis and to increase the fee for reclaiming property to \$10</p>
<p><a href="#"><u>STA 502-11</u></a></p> <p>Vending Machine Refunds</p>	<p><b>Revision of Policy</b></p> <p>Revised to include all vending machines on campus</p>
<p><a href="#"><u>STA 503-03</u></a></p> <p>Sparky’s Den Recreation Center</p>	<p><b>Revision of Policy</b></p> <p>Revised to update the name of the policy to the name change of the center</p>
<p><a href="#"><u>STA 602-09</u></a></p> <p>Withdrawal from Classes for Medical/Compassionate Reasons</p>	<p><b>Revision of Policy</b></p> <p>Revised to stress that medical withdrawal is to be used only in extraordinary circumstances and to state that the dean’s designee may impose conditions before granting readmission</p>

<p><a href="#">STA 802-13</a> Financial Aid Reviews</p>	<p><b>Revision of Policy</b> Revised to remove items that are no longer considered for review in adjustments to a student’s household or income information</p>
<p><a href="#">STA 1002-09</a> Involuntary Withdrawal from the University in Special Circumstances</p>	<p><b>Revision of Policy</b> Revised to include the possibility of readmission under specific conditions and to include contacting parents subject to FERPA guidelines</p>
