<a href="#">STA 001</a> Introduction	<b>Revision of Policy</b> Revised to update “registrar” to “university registrar” and “Office of the Registrar” to “Office of the University Registrar”
<a href="#">STA 104-01</a> <i>Student Code of Conduct</i> and <i>Student Disciplinary Procedures</i>	<b>Revision of Policy</b> Revised to update “registrar” to “university registrar”
<a href="#">STA 106-01</a> Immunization Requirements	<b>Revision of Policy</b> Revised to delete the requirement for proof of rubella immunity
<a href="#">STA 106-03</a> Alcohol and Other Drugs on Campus	<b>Revision of Policy</b> Revised to state that students, faculty, staff, and visitors are required to obey ASU policies regarding alcohol and other drugs in addition to state laws and to delete Cholla Hall and Saguaro A, B, and C wings as campus housing where alcohol may be consumed
<a href="#">STA 106-04</a> Insurance Requirements for International Students	<b>Revision of Policy</b> Revised to update “registrar” to “university registrar” and “Office of the Registrar” to “Office of the University Registrar”
<a href="#">STA 301-02</a> Psychiatric Services	<b>Revision of Policy</b> Revised to clarify that Counseling and Consultation staff will work with counseling clients who meet financial eligibility criteria to facilitate their receipt of no-cost medication through external support programs

<p><a href="#">STA 301-03</a></p> <p>Career Testing Services</p>	<p><b>Revision of Policy</b></p> <p>Revised to update the language, “Student Testing Services” to “Career Testing Services,” and “Nonstudent and Alumni Testing Services” to “Fees for Testing Services” and to include students under this header; to clarify the tests and workshops provided; to delete the “Testing Location” section, that fees are assessed for any testing undertaken at the request of a student’s counselor at Counseling and Consultation, that the fee may be waived if the counselor determines the student is unable to pay, and individual interpretation sessions as an option for receiving testing results; and to include a section on “Registration, Fee Payment, and Testing Procedures”</p>
