STA 1001-01 Fraternities and Sororities—Relationship with the University	Revision of Policy Revised to update the language; to add three new expectations (that each fraternity and sorority will provide the appropriate office with a complete chapter roster, pay university obligations within 60 days of being issued a statement, and participate in philanthropic activities); to state that all recognized chapters in good standing are granted verification of members' ASU enrollment; and to clarify that the policy refers to social fraternities and sororities, that chapters may be members of a council, and that a copy of chapter liability insurance must be provided to the appropriate campus office before the expiration date
STA 1102-02 <i>State Press</i> Letters to the Editor Policy	Revision of Policy Revised to update the language and to state that indecent or personally damaging letters will not be accepted; that letters to the editor will be authenticated by staff who will contact the letter writers at the provided phone numbers or e-mail addresses; and that comments published in the "Talk Back" section may be anonymous, but the editor will attempt to verify authenticity before publication
