<p><u>STA 402-08</u></p> <p>Alternative Print Formats, Recorded Textbooks, and Texts for Interpreter Preparation</p>	<p>Revision of Policy</p> <p>Revised to clarify the process of RFB&D services and student responsibility</p>
<p><u>STA 405-02</u></p> <p>Eligible Veterans Upward Bound Program Participants</p>	<p>Revision of Policy</p> <p>Revised to include the definition of a veteran</p>
<p><u>STA 602-02</u></p> <p>Instructor-Initiated Drop of a Student for Nonattendance</p>	<p>New Policy</p> <p>Sets forth a procedure for instructors to drop a student for nonattendance</p>
<p><u>STA 602-05</u></p> <p>Registration and Drop/Add after the Published Deadline</p>	<p>Revision of Policy</p> <p>Revised to allow approval from an authorized designee of a dean to keep wording of policies consistent</p>
<p><u>STA 602-07</u></p> <p>Administrative Registration Holds on Student Enrollment</p>	<p>Revision of Policy</p> <p>Revised to add an administrative registration hold on a student’s record to step 2 in the procedure</p>
<p>STA 603-07</p>	<p>Deletion of Policy</p>

<p><u>STA 604-08</u></p> <p>Affidavit of Dependency for Release of Records</p>	<p>Revision of Policy</p> <p>Revised to add FERPA to the sources and to clarify the position that release of records is “possible”</p>
<p><u>STA 605-01</u></p> <p>Undergraduate Program of Study</p>	<p>Revision of Policy</p> <p>Revised to establish policy for students who follow curriculum requirements of the 1994-96 catalog or earlier editions</p>
<p><u>STA 605-02</u></p> <p>Master’s and Doctoral Programs of Study</p>	<p>Revision of Policy</p> <p>Revised to update terminology for the petition procedure</p>
<p><u>STA 605-06</u></p> <p>Verifying Degree Completion—Doctoral Candidates</p>	<p>Revision of Policy</p> <p>Revised to update the procedure, to state that current semester confirmation is no longer needed, and to state that grades are reported through the class roster</p>
<p><u>STA 605-08</u></p> <p>Awarding Posthumous Degrees</p>	<p>Revision of Policy</p> <p>Revised to change the procedure</p>
<p><u>STA 605-09</u></p> <p>Declaration of Graduation</p>	<p>Revision of Policy</p> <p>Revised to change the period when the Declaration of Graduation must be filed</p>
<p><u>STA 606-01</u></p> <p>Residency Reclassification—General Policy</p>	<p>Revision of Policy</p> <p>Revised to include full-time certified teachers or noncertified classroom aides as meeting domicile requirements</p>
<p><u>STA 607-01</u></p> <p>Eligibility for Veterans Affairs Educational Benefits</p>	<p>Revision of Policy</p> <p>Revised to clarify that undergraduate students may attend two semesters pending evaluation of prior credit and course of study</p>
