<p>STA 104-03</p> <p>Hazing Prevention</p>	<p>Revision of Policy</p> <p>Revised to state that violations must be reported to the appropriate campus office, to reformat the “Definitions” section, to update two cross-references, and to delete a cross-reference</p>
<p>STA 104-04</p> <p>Protocol for Response to Student Victims of Sexual and Relationship Violence</p>	<p>Revision of Policy</p> <p>Revised to update “ASU Student Health” to “Campus Health Service” and “East campus” to “Polytechnic campus,” to clarify that the ASU Home Safe Violence Prevention and Advocacy Center is located on the Tempe campus, and to state that victimized students should be encouraged to contact the Office of the Dean of Students</p>

<p>STA 106-01</p> <p>Immunization Requirements</p>	<p>Revision of Policy</p> <p>Revised to update “Student Health and Wellness Center (SHWC)” to “Campus Health Service (CHS)” and “East campus” to “Polytechnic campus”</p>
<p>STA 106-02</p> <p>Human Immunodeficiency Virus Infection</p>	<p>Revision of Policy</p> <p>Revised to update a source and to delete a cross-reference</p>
<p>STA 106-03</p> <p>Alcohol and Other Drugs on Campus</p>	<p>Revision of Policy</p> <p>Revised to update the language, “East campus” to “Polytechnic campus,” and the information regarding leased fraternity housing; to clarify that the policy applies to all campuses; to add wine as a possible allowed beverage at authorized tailgate parties; and to delete references to campus-specific education and treatment programs and facilities</p>
<p>STA 202-02</p> <p>Career Services Eligibility</p>	<p>Revision of Policy</p> <p>Revised to update the source, the language, and “Career Services” to “campus career centers” and to state that ASU alumni who have graduated within the last 12 months are eligible for up to three appointments and that career centers are located only at the Tempe and Polytechnic campuses</p>
<p>STA 202-04</p> <p>Employment Opportunity Listings</p>	<p>Revision of Policy</p> <p>Revised to update the source, the language, and “Career Services” to “campus career centers”</p>

<p>STA 602–01</p> <p>Danforth Chapel Use</p>	<p>Revision of Policy</p> <p>Revised to update the policy number from 406–01 and the source and to clarify that Danforth Chapel is located on the Tempe campus</p>
<p>STA 602–02</p> <p>Campus Interfaith Council—Faculty Associate Card</p>	<p>Revision of Policy</p> <p>Revised to update the title, the policy number from 406–02, the source, the language, and “Danforth Chapel secretary” to “Student Life” in the procedural tables and to clarify that up to two individuals per ministry may be issued a faculty associate card</p>
<p>STA 703–02</p> <p>Entering Student Rooms</p>	<p>Revision of Policy</p> <p>Revised to update a source and the language and to delete the requirement for 24 hours’ notice before entering rooms to enforce safety and health standards</p>
<p>STA 803–03</p> <p>Eligible Educational Opportunity Center Participants</p>	<p>Revision of Policy</p> <p>Revised to update the policy number from 403–03</p>
<p>STA 804–03</p> <p>Eligible Upward Bound Program Participants</p>	<p>Revision of Policy</p> <p>Revised to update the policy number from 404–03</p>

<p>STA 805-02</p> <p>Eligible Veterans Upward Bound Program Participants</p>	<p>Revision of Policy</p> <p>Revised to update the policy number from 405-02</p>

<p>STA 1001-01</p> <p>Fraternities and Sororities— Relationship with the University</p>	<p>Revision of Policy</p> <p>Revised to update the policy number from 504-01, the language, and “Greek Life Office” to “appropriate campus office”; to add a link, that the appropriate campus office may assign fees for various administrative tasks, and a note that support cannot be provided to unrecognized or sub-rosa organizations; and to delete a source, the “Student Development Support for the Fraternity/Sorority Community” section, the expectation that only university faculty and staff may fill the position of primary advisor but affiliated alumnus may fill the secondary advisor position, and references to the Student Organization Resource Center</p>
<p>STA 1002-01</p> <p>Student Organization Registration</p>	<p>Revision of Policy</p> <p>Revised to update the policy number from 505-01, the source, and the language; to add a note that registration does not constitute university endorsement or approval but rather the organization’s willingness to comply with state law and the rules, regulations, and policies of the university and the Board of Regents; to state that campus organizations should see the appropriate campus office for registration information and that religious student organizations that limit membership or leadership positions to students who share the same religious beliefs may register so long as they do not discriminate in membership or leadership on any other prohibited basis; and to delete references to the Student Organization Resource Center, procedural information, and a cross-reference</p>
<p>STA 1303</p> <p>Student Recreation Complex</p>	<p>Revision of Policy</p> <p>Revised to update the language, “Recreational Sports” to “Campus Recreation,” and “East campus” to “Polytechnic campus”; to clarify that the Student Recreation Complex is located on the Tempe campus, that a secondary member is any person who purchases a membership with sponsorship from a primary member, and that a secondary member who pays the appropriate fee for full or limited access membership is eligible; and to delete references to specific campuses when addressing faculty and staff of ASU</p>

STA 301-01, 301-02, 301-03, 301-04, 301-05, 302-03, 302-05, 302-08, 302-09, 302-10	Revision of Policies Revised to update “East campus” to “Polytechnic campus”
