BLUSH, CHARLES (Karl Blesch), born at Schwabhausen, Baden, Germany, about 1837; enlisted, at New Orleans, January 24, 1855 to serve 5 years in the U. S. Army; assigned to Company K. 7th U.S. Infantry; participated in the Utah expedition commanded by Brigadier General Albert Sidney Johnston, 1857; prometed to Musician April 23, 1858; honerably discharged at Camp Fleyd, Utah Territory, January 24, 1860.

Enlisted, age 25, at Placerville, Elderade County, California, October 14,1861, to serve 3 years ea Musician, Company G, 5th California Infantry; stationed at Camp Union (Sacramente) until February, 1863; west to Southern California with the Company and Orrived in Tucsen in April; remained there until August and then marched to Fort Bowie where the Company was O tationed until January, 1863, when it went on to the Rie Grande; at Fort Craig until Juno and then marched to El Paso, Texas; returned to Las Cruces, N.M., where he was honorably discharged, May 27, 1864.

Reenlisted, February 25, 1865, at San Francisco, to serve 3 years as Private, Company B, 4th California Infantry; © tationed at Drum Barracks until April and them went with the Company to Fort Gaston in Humboldt County; returned to the Presidie of San Francisco for muster out of the Company where he was honorably discharged April 18, 1866; naturalised as an American citison in the 4th Judicial District Court, September 3, 1866.

Halisted on May 11,1867, in the U.S. Navy at San Francisco, California, for 3 years, es landsman; served on the 'SUMADER, and after the wreck of that ship, on the PENSACOLA and MOHONGO until honorably discharged as an ordinary seaman at Mare Island, California on May 26, 1869.

Returned to Arizona and was a registered veter at Agua Caliente, Maricepa County, 1876-78; moved to the SaltRiverValley in 1880 where his

name Oppears in the Census as a laborer, age 43; he located the S.E. 1/4 of Section 7, T.IN.R.2 L. as a homestead for which ho obtained a patent on November 9, 1891; Comrade, J. W. Owen Post No.5, G. A.R., Phoenix; admit ted from Phoenix to the Pacific Branch, U.S. Soldiers Home, Sawtelle, California on March 30, 1896, where he died, December 25, 1897, aged 62; buried, Soldiers Home Cemetery.
