

BUCKMAN, JOHN H

Born at Franklin Kentucky January 1, 1824, 18 (about 1824)

Son of John James Buckman and Frances

Married, Sarah Russell - third wife Ft. Scott, Union Town, Ky.

on Feb. 19, 1855, 1855, who was born in Indiana about 1840.

Children, Thadus, John J., Jr., Thomas P., Mary Ann (Mrs. Henry Clay),

Celia R., (Mrs. Alonzo Bennett), and Frances (Mrs. Frank J. Scott).

Andrew, died, and Henry, died

Came to Prescott, A.T., September 17, 1864; kept the stage station at Fort Rock where he was wounded in the groin during an Indian attack in the fall of 1866; William G. Poindexter, Patrick McAteer, Ed. May, and a soldier helped to defend the place which was besieged all day during which his son, Thad, was also wounded.

Listed, U. S. Census, 1870, at Prescott, age 46, born in Kentucky, occupation - Farmer; was stabbed severely in the face by Patrick Flynn in Prescott, April 17, 1874.

Died at, Yavapai County, A.T., July 17, 1900.

Buried Thompson Valley near Yava Cemetery
