## COUES, ELLIOTT

COUES, EILICTT, born in Portsmouth, Rockingham County,
New Hampshire, September 9, 1842; son of Samuel Elliottend
Charlotte Haven (Ladd) Coues; married (1) Sara A. Richardson,
from whom he was divorced on October 24, 1864, by an Act of the
lst. Arisona Territorial Legislature; (2) Jane Augusta McKenney
on May 3, 1867, and (3) Mrs. Mary Emily Bates, October 25,1887;
daughter, Edith, who married Nelson O'Shaughnessy, Charge de
Affaires in Mexico, 1913-14.

After attending Gonzaga Seminary he entered Columbian

College (now George Washington University), Washington, D.C., and
received an A.B. degree in 1861; pointed Medical Cadet, May 8,

1862, while a student, and served until May 8, 1863, when he received an M.D. degree; appointed, age 21, 1st. Lieutenant, Assistant

Surgeon, U.S. Army, April 14, 1864, and ordered to Fort Whipple,

A.T., where he served as Post Surgeon from July, 1864 to October,

1865.

Brevet Captain, March 15, 1865, for faithful and meritorious service during the war and promoted to Captain, Assistant Surgeon, March 20, 1867; stationed at Fort Macon, North Carolina, 1869-70; was with the Survey West of the 100th Meridian under Lieutenant George M. Wheeler in 1871 end wrote chapter 5 of the report of that Expedition entitled "Reptiles and Bactrachians of Arizona"; served as Surgeon and Naturalist, U.S. Northern Boundary Commission, 1875-76; Secretary and Naturalist, U.S. Geological and Geographic Survey of the Territories under Francis V. Hayden, 1876-80; his "Birds of the Colorado Valley" was published in 1878" containing some of the finest bird biographies that have ever appeared as well as some

beautiful examples of English prose writing."

Returned to Arisona and was stationed at Whipple Barracks, from December, 1880, to February, 1881; • t Fort Nohave from February 25 to March 19, and at Fort Verde until May 30; in the field scouting with Lieutenant Colonel William Redwood Price \* sexpedition to June 30; at Whipple Barracks to July 13, and again in the field with Colonel Price; at Camp Hualapai • nd Camp Garfield to August 22, returned to Washington, D.C., where he resigned from the Army November 17, 1881.

Beginning about 1890 he wrote a series of 15 volumes on early travel in the West the last of which was "On the Trail of a Spanish Pioneer - The" Diary of Francisco Garces"; his health gave away while in Arizona in a search for material for this work which was not published until after his death.
