

FERRIS , WASHINGTON KNAPP

Born at _____, New York, _____, 1820.

Married, Mrs. Frances Wooden of Calhoun County, Michigan,

Ot Antelope Valley, Yavapai County, A.T., June 17, 1879, from

whom he was divorced at Prescott on March 29, 1888, because

she "left the Territory for parts unknown" in 1880.

Came to Arizona in 1864 ; the Prescott Arizona Miner printed

the following items about him:

September 5, 1868 -- W. K. Ferris, of Wickenburg, is going to California on business. He will return in about two months.

October 3,1868 -- Mr. Ferris, of Wickenburg, brought the mail from Wickenburg to Prescott last week, and remained for several days. Mr. F. has occupied the position of mail and stage agent at Wickenburg for some time past with satisfaction to his employer, Jas. Grant, and the public.

June 11, 1870 -- W. K. Ferris, who left this Territory some time ago, and went to New Zealand on a gold venture, has returned to his former home at Wickenburg, satisfied that it is much easier to get gold here than in New Zealand. Mr. Ferris is a good man and It pleases us to know that he is once again a citizen Or Arizona.

January 8, 1875 -- Mr. Ferris came in on Saturday last with the mail on the new route from Wickenburg via Walnut Grove, Bradshaw, Bully Bueno quartz mill to Prescott. This is a weekly mail leaving Prescott on Sunday mornings and leaving Wickenburg Thursdays.

January 18, 1878 -- Judge Ferris, who has the contract for carrying the mail between Prescott and Wickenburg via Bradshaw and Walnut Grove once a week, and return, has made a trip each week for three years and a half, up to the first day of January, 1878, without missing a single trip. Mr. Ferris has carried the mail without any assistance, on horseback, traveling 200 miles weekly for 172 consecutive weeks, which aggregates the nice little distance of 34,400 miles. It can truthfully be said of Mr. F. that he has been a true and faithful servant.

FERRIS, WASHINGTON KNAPP - 2 -

January 17, 1879 -- W. K.Ferris, who for so many years well and faithfully carried the mail between Prescott and Wickenburg, and now an honest tiller of the soil, with headquarters at his ranch, Minnehaha Flat, came into the city yesterday and greeted his old friends with a pleasant smile and hearty shake of the paw. He informs us that the new saw mill at the Flat will soon be put intomotion and the manufacture of lumber commenced In earnest.

June 20, 1879 (communicat ion from Antelope valley)--The good people of this Valley have been considerably excited for the past week, owing to the approaching nuptials of an old Hassayamper, Judge Ferris. The wedding took place last evening at the residence of Dr. Pierson, and was attended by the elite of the valley, and all seemed to enjoy themselves hugely; dancing and merry making were kept up until midnight, when ye goodly company, singly and en masse, congratulated the Judge and his estimable lady and dispersed. Later the bride and groom were surrounded by the "Valley Glee Club" which called forth the Judge, who with his accustomed liberality "set up" the wine, and the club gave three cheers and a tiger.

The <u>Prescott Courier</u> of June 22, 1886, stated:

W. K. Ferris. a pioneer of 164, has come to Prescott from his place in Bradshaw Mountains, 45 miles south of Prescott.

His name appears on the Great Register of Yavapai County

in 1888 as a resident of Prescott, age 68.
