SHINN, JOHN BROGNARD, born at Bordentown, Burlington County, New Jersey, March 6, 1835; son of Joseph Biddle and Rebecca Stratten (Cline) Shinn; married Janet Bryan Street at Beaufort, North Carolina, January 15, 1874; son, John B., and daughter, Mrs. S. D. Cushing.

Removed with his parents to Hillsboro, Highland County, Ohio, about 1850; Cadet, U. S. Military Academy, West Point, New York, 1852-56; Brevet 2d Lieutenant of Artillery July 1, 1856; appointed 2d Lieutenant, 3d U. S. Artillery, September 1, 1856; served on frontier duty at Fort Yuma, California, 1856-57; at Fort Leavenworth quelling Kansas disturbances, 1857-58; at Fort Ridgley, Minnesota, 1858-59, including march to Sioux Agency; at Fort Vancouver, West., 1859-1861; promoted 1st Lieutenant, 3d U. S. Artillery, May 30, 1860; mustering officer for California, August 29 to November 5, 1861; in garrison at San Francisco Harbor, Movember 1861.

as Light Artillery under his direction at Benecia Barracks in December and moved to the Presidio of San Francisco with four brass field pieces and 80 horses early in January, 1862; sent to Southern California and was at San Pedro in February; on practice march from Camp Drum to Camp Latham and return March 25 to 28, 1862; crossed the desert late in April and arrived at Fort Yuma May 3, 1862; left Fort Yuma with the following ammunition in the caissons of the Battery: 50 rounds

of 6-pounder shot, 40 rounds of 6-pounder case shot, 10 rounds of 6-pounder cannister shot, 40 rounds of 12-pounder case shot, 30 rounds of 12-pounder shells and 8 rounds of cannister for howitzers; a reserve supply of ammunition was carried in the wagon trains.

Reached Fort Barrett May 31 and left there at 4:15 p.m., June 1. with the Battery, an ambulance, a 600 gallon water tank, 8 transportation wagons, 87 men and 153 animals; marched viba Sacaton, Oncida Station, Blue Water Station, Picacho (where a dry camp was made). Point of Mountain and arrived at Tucson at 8:45 a.m., June 5, 1862, total distance, 86.7 miles: left Tucson in the Jecond Command of the Column from California with the Battery and 73 men, July 21, 1862: marched to the Rio Grande and thence to Albuquerque: promoted Captain, 3rd U. 3. Artillery, January 20, 1864; at Albuquerque. New Mexico, November 1862 to October 1865; Brevet Major for arduous and meritorious services in successfully bringing his Battery across the Yuma and Gila Deserts and for faithful services in New Mexico. March 13, 1865; making survey of Indian Reservation at Bosque Redondo on the Pecos River, October 8, 1865 to October 21, 1866; in garrison at Fort Independence, Massachusetts: Fort Monroe, Virginia; and Key West, Florida, 1866 to 1870; honorably discharged at his own request on December 27, 1870.

Draughtsman and Civil Engineer at Newbern, North Carolina, 1871-79; entered on duty as Clerk, General Land Office,

Washington, D. C., August 1, 1879, and served in that capacity until his death; died at his residence, 1755 Church Street, Washington, D. C., November 1, 1904, aged 71; buried, National Cemetary, Arlington, Virginia; W. D. 887,082, Series 1, Vol. 4, 9, 34, 41, 48, 50.
