**Athlete Code of Conduct**

**As a participating athlete in the ASU Sport Club Program, I agree to abide by the following:**

- **I will conduct myself accordingly, responsibly, and professionally, at any and all Sport Club sponsored activities. These include home and away matches, as well as any extracurricular activities.**
- **I understand that my actions may adversely affect my team, the Sport Club Program, Campus Recreation and Arizona State University.**
- **I will represent ASU, the Division of Student Affairs, Campus Recreation and my team in a professional, positive manner.**
- **I will show respect to all competition officials, opposing team members, spectators and Campus Recreation employees.**
- **I will adhere to all Campus Recreation policies and procedures. These include; the Sport Club Manual, SRC Facility policies and procedures, and all other university policies and procedures, including the Student Code of Conduct.**
- **In accordance with ASU Alcohol and Hazing policies, I recognize that the Campus Recreation and the Sport Club Program observe a NO TOLERANCE RULE. I also understand that failure to comply will adversely affect my team and myself.**
- **I understand that my actions may adversely affect my ability to participate in any of the aforementioned programs and/or remain as a functioning entity of Arizona State University's Sport Club Program.**

I understand that if I do not adhere to the above guidelines than the following consequences may occur. I also understand that the following consequences are not progressive, meaning that one does not have to precede the other. The severity of the offense will determine whether other entities become involved. I understand that Campus Recreation reserves the right to inform campus officials of infractions, and that those decisions are independent of any decisions made by Campus Recreation and the Sport Club Program.

**Individual Violations**

- Probation and placement on contract by the Assistant Director for Intramurals & Sport Clubs.
- Community Service hours assigned by the Assistant Director for Intramurals & Sport Clubs.
- Suspension from sport club activity for duration of time based upon severity of offense.
- Removal from the Competitive Sport Club Program.
- Referral to Student Judicial Affairs for university disciplinary action.

**Team Violations**

- Probation and placement on contract by the Assistant Director for Intramurals & Sport Clubs.
- Community Service hours assigned by the Assistant Director for Intramurals & Sport Clubs.
- Forfeiture of a number of competitions based on the severity of the offense.
- Forfeiture of activities, privileges or services provided to team (including competitions, facilities, and finances)
- Suspension of team from the Sport Club Program.
