## **Overview**

Arizona State University Employee Health has collaborated with the ASU Art Museum to host its second annual **employee art contest**. The contest is open to all ASU employees and is intended to highlight the artistic creativity of faculty and staff. The contest consists of five categories:

- 1. Painting watercolor, acrylic, oil, etc.
- 2. Drawing ink, charcoal, etc.
- 3. Photography.
- 4. Print.
- 5. Sculpture.

#### ASU employees should submit artwork illustrating this theme — ASU across the globe.

**Scoring instructions**: A 100-point scoring system will be used to determine the highest-scored submissions for all categories. Artwork will be judged on the following criteria:

- **Overall impact**: How effective was the artwork in capturing your attention? Did it cause you to reflect on the topic? 40 points.
- **Connection to the theme**: Did the artwork relate to the chosen theme and reflect a positive tone? 40 points.
- Creativity and originality: How well do the visuals conveythe message? 20 points.

Winners will be notified by **Friday**, **Nov**. **18**, **2022**, and will receive an award in recognition of their achievement. The winning artwork will be displayed for one year at the ASU Employee Health medical office located at 1492 S. Mill Ave., Suite 105, Tempe, Arizona.

## **Contest rules**

- 1. Each contestant must submit an entry form with the entry. Each contestant may submit up to three pieces for consideration. Submit one entry form per submission. Collaborative artwork from multiple employees is permitted.
- 2. Submissions cannot be larger than 48" x 36" in size, provide a positive message and relate to the contest theme. All artworks must be ready to hang, if applicable, and appropriate for display in an ASU clinical setting. An ASU Employee Health Contest Information Form is included in this registration packet and must be filled out in its entirety, be legible and submitted with the artwork.
- 3. ASU Employee Health **must receive** submission materials no later than **Friday**, **Nov. 4**, **2022**.
- 4. Entries postmarked after the deadline will not be accepted.
- 5. Entries must be addressed to ASU Employee Health, Environmental Health and Safety and **delivered by appointment** to ASU University Services Building at 1551 S. Rural

Road, Tempe, AZ 85287. Entries may also be mailed to P.O. Box 876412 Tempe, AZ 85287. Entries **must be** mailed flat. **Do not fold prints or canvases**. Participants will not be reimbursed for postage.

- 6. Only original artwork will be accepted.
- 7. Artwork **will not** be returned by mail. Artwork may be picked up by appointment at ASU University Services Building, 1551 S. Rural Road, Tempe, AZ 85281. Artwork **will not** be available for pick up after **Dec. 2, 2023.** Any artwork that is not picked up will become the property of ASU Environmental Health and Safety.
- 8. Employees participating in the contest should do so on their own time and not during ASU work hours.

Participation in the employee art contest is strictly voluntary. Employees who participate in the contest will not be compensated for working on or submitting artwork and will not be compensated or reimbursed for related expenses.

#### Artwork submission deadline

Friday, Nov. 4, 2022 — entries postmarked after the deadline will not be accepted.

Friday, Nov. 18, 2022.

#### Contest winners' artwork on display

Tuesday, Nov. 30, 2022-Nov. 30, 2023, at the ASU Employee Health medical office.
