LORD , CHARLES H _____

Born at Boonville, Oneida County, New York, January 20, 1832.

Son of Dr. Ralph and Sarah Lord.

Married Anna Eliza Austin (1839-1924) Allegany, New York, April 30, 1857.

Children, Herbert, Howard and _____ (Mrs. Charles McNamee)

Served from October 15, 1861 to May 7, 1862, as Assistant Surgeon, Wisconsin Infantry, and from January 1, 1863 to May 12, 1864, as Surgeon, New York Infantry; was paid as contract Surgeon from October 12 to December 11, 1864, while en route from Washington, D. C. to Tubac, A. T. Surgeon at Enriquita (Cerro Colorado) Mine, A. T., May 10, 1866; and served as Postmaster at that place from May 7 to December 19, 1866, when he was succeeded by C. L. Evans; listed, U. S. Census, June, 1870, at Tucson, age 37, born in New York, occupation, Retail Merchant and Territorial Auditor, property valued at \$30,500; with W. W. Williams formed the partnership of Lord & Williams, which became the greatest wholesale and retail general merchandise and banking house in southern Arizona, 1867-81. Succeeded W. W. Williams as Postmaster at Tucson, September 24, 1869, and served until January 8, 1884; served as United States Depository for the Treasury at Tucson from October 8, 1869 to November 30, 1881. Died at the City of Mexico, March 29, 1884, aged 52. Buried, American Cemetery, City of Mexico, Mexico.
